2. PUBLIC COMMENTS ON NON-AGENDA MATTERS

Jon Kaufman representing the Alliance of FireSafe Councils: This month, AFSC will secure a proposal for a Vegetation Management Plan created collaboratively by: Ascent, The Estuary Institute and Tukman Geospatial. The AFSC will forward the plan to EBWC for consideration. If EBWC approves the proposal, it would enable the EBWC to move ahead with vegetation management programs without the need to gain CEQA compliance.

Gary Frost representing Make El Cerrito Fire Safe: At 9/23/24 EBWC meeting presenter Niccolo De Luca suggested he write a draft letter to Insurance Commissioner Lara to come up with ideas for how to keep insurance rates under control. Gary recommended that the group follow-up with Niccolo accordingly.

Matt Kelly representing Contra Costa Transportation Authority (CCTA): Caltrans awarded CCTA a grant to prepare an emergency evacuation plan for Contra Costa County. CCTA will create a plan with wildfire, earthquake, and Tsunami in mind. They will focus, among other things, on a county wide smart signals program so key signals will be coordinated during an evacuation. CCTA is doing outreach to share the information to groups such as EBWC while the \$1.7M grant is pending. Once the grant is finalized, CCTA will be reaching out to EBWC as a stakeholder.

Kelly Hammargren requested that the next meeting be set up for live transcription and offered her help, if needed, to get it set up.

The EBWC will establish a process for reimbursing the Fiscal Agent for its actual costs and expenses accrued in performing its duties under the MOU, including for staff time based on then-current hourly rates of compensation.

7. PRESENTATION: FUELS MANAGEMENT IN ALAMEDA AND CONTRA COSTA COUNTIES (Mark Tukman, Tukman Geospatial)

Tukman Geospatial has developed data sets and new tools for Contra Costa and Alameda Counties, including wildfire hazard modeling, risk to structure modeling, and the best available maps, drilling down even to the parcel level, in order to support jurisdictions to strategically manage vegetation to reduce wildfire threat. Funders include EBRPD, CAL FIRE and the State Coastal Conservancy.

• Education: Create community engagement program to inform property

owners, and decision-makers, about the value of home hardening and defensible space including "zone zero"

- Legislation: Support adoption of state, county and local ordinances to promote consistent region-wide risk reduction measures in wildfire hazard zones
- Funding: Promote and support a regional assistance program for qualified homeowners to help establish ember-resistant zones within five feet of structures, or "zone zero"

Vegetation Management

- Funding: Promote implementation of best practices for various vegetative types, raise funds for situational analyses, plans for a CEQA-compliant, ecologically-sound, region-wide vegetation management plan
- Project management: Apply for grants, distribute funding and support activities

INTEREST AREAS

- 1. Strengthen local building & fire codes and adherence
- 2. Promote the implementation of ecologically sound, science-driven vegetation management priorities
- 3. Support evacuation & response programs
- 4. Secure new funding for regional priorities
- 5. Advocate for local and state legislation
